2018 Property Tax Information

Enclosed is your 2018 property tax bill.

If you have sold your property in 2018 and you receive a tax bill, please forward the tax bill to the new owners, or return the tax bill to the Town of Hartford office.

Make checks payable to the TOWN OF HARTFORD. First installment payments are due January 31, 2019. To avoid waiting in line, please send your payment by mail, use the e-check option or the credit card option on the Town of Hartford website located at www.tn.hartford.wi.gov under the Tax Payments icon, or use drop box located by the **MAIN ENTRANCE** of the Town Hall building, or at the **LANDMARK CREDIT UNION** in **HARTFORD. DO NOT PUT PAYMENTS IN OVERNIGHT DEPOSIT BOX OR GIVE TO THE TELLERS. USE SPECIFIED BOX LOCATED INSIDE BANK LOBBY ONLY.**

Enclose the proper stub which indicates first installment or full payment. Also, **please include a self-addressed stamped envelope for return of your receipt, or you are able to print your own receipt by following the instructions on the enclosed flier.** A return envelope is enclosed for convenience in mailing your payment.

A \$35.00 fee will be charged for any check returned for insufficient funds.

Escrow payments made payable to the property owner and the Town of Hartford must be properly endorsed by the owner or owners before mailing to the Town Treasurer. If the escrow payment is greater than the amount of the bill, a refund check will be mailed within 15 days. Overpayments less than \$5.00 will not be refunded unless requested.

We have implemented availability of paying your taxes using **e-checking** at a flat rate of \$1.50 per transaction. You can pay on-line using your **credit card** at www.tn.hartford.wi.gov and choose the **tax payment icon, OR** call 866-898-2913. When you use the phone system, you will need to have your tax bill in front of you since you will need to reference your bill number for the parcel you are paying. It is listed on your tax bill and is five digits long. **Also note there is a fee associated with all Credit Card payments of 2.39% of your payment amount.**

Please note this icon is for Tax Payments only, **NOT for paying your utilities or other payments owed to the town or utility districts.**

DOG LICENSES: Dog License fees for 2018/2019 are as follows:

Neutered males	\$5.00	Unneutered males	\$12.00
Spayed females	\$5.00	Unspayed females	\$12.00

PROOF OF VACCINATION PAPERWORK FROM YOUR VET MUST ACCOMPANY ALL APPLICATIONS. **A late fee of \$10.00 will be charged for dog licenses applied for after April 1, 2019.** If paying in person, please have your dog applications filled out prior to arriving at the office INCLUDING RABIES NUMBER AND EXPIRATION DATE. If you send your payment separate from your tax payment, please include a self-addressed stamped envelope for your return dog tag. Failure to obtain a dog license for your dog(s) will result in a call from our Town Police, and a possible citation issued for delinquency.

Applications will be mailed in the enclosed tax billing. If you do not have them in this envelope, or if you obtained a new dog, please contact the Town office and an application will be mailed to you or you can pick an application up during regular office hours.
